**RESOLUTION OF THE BOARD OF FIRE
COMMISSIONERS, HAZLET TOWNSHIP DISTRICT
NO. 1, COUNTY OF MONMOUTH, STATE OF NEW
JERSEY, REJECTING BID CONTRACT.**

WHEREAS, the Hazlet Township Fire District Board of Commissioners (hereinafter "Board" or "District") had previously solicited bids to finance an apparatus, in accordance with the applicable statutes, regulations, and Local Finance Notices; and

WHEREAS, on September 18, 2024, the District received four bids, with Community Leasing Partners being the lowest of the bids; and

WHEREAS, complications arose that required Community Leasing to revise the previously proposed payment schedule; and

WHEREAS, the District and Community Leasing Partners are currently at an impasse regarding the contractual terms regarding the financing for the apparatus; and

WHEREAS, pursuant to the Local Public Contracts Law, including but not limited to N.J.S.A. 40A:11-24, the District has the right to reject the bid in the event of a contract dispute resulting in the contract being unsigned by all parties.

NOW, THEREFORE BE IT RESOLVED as follows:

1. The District is rejecting the proposed contract submitted by Community Leasing; and
2. The District shall explore other financing options, including but not limited to, re-bidding for the project at a later date; and
3. A copy of this Resolution shall be provided to the New Jersey Division of Community Affairs.
